Registration fees

Refund policy

Once we have received your application form and processed your registration fee, we will communicate to you either by e-mail or by post that your place on the course has been reserved successfully.

Should your application being denied by Percussity Ltd. due to oversubscription or unsuitability on the course, your registration fee will be REFUNDED TO YOU IN FULL. However, once your place at the course has been reserved and you decided before March 31st 2010 that you could no longer attend due to reasons not pertinent to Percussity Ltd, you will be refunded your fee less £100 which will be detracted for our admnistration costs.

IN THE EVENT YOU DECIDED NO LONGER TO ATTEND THE COURSE AFTER MARCH 31st 2010, your registration fee WILL NOT be refunded to you and your place on the course will be reallocated to another applicant, should this be possible.
